

## **High School Completion Status and Identity and Statement of Education Purpose**

**Instructions:** You have been selected by the Department of Education to provide proof of High School Completion and Identity and Statement of Educational Purpose.

**Section A:** You must provide one of the acceptable documents listed below.

**Section B:** You must come to Central Penn in person with proper identification or go to a Notary with proper identification and the document below.

### **Section A: High School Completion Status**

Provide one of the following documents that indicate the student's high school completion status when the student will begin college in 2021–2022:

- A copy of the student's high school diploma.
- A copy of the student's final official high school transcript that shows the date when the diploma was awarded.
- A copy of the student's General Educational Development (GED) certificate or GED transcript that indicated the student passed the exam, or a state-authorized high school equivalent certificate.
- An academic transcript that indicates the student successfully completed at least a two-year program that is acceptable for full credit toward a bachelor's degree.
- For a homeschooled student from a state where state law requires the student to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), a copy of that credential.
- For a homeschooled student from a state where state law does not require the student to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), a transcript or the equivalent, signed by the student's parent or guardian, that lists the secondary school courses the student completed and includes a statement that the student successfully completed a secondary school education in a homeschool setting.
- For students who completed secondary education in a foreign country, a copy of the "secondary school leaving certificate" or other similar document.

If the student is unable to obtain the documentation listed above, he or she must contact the financial aid office.

**Identity and Statement of Educational Purpose
